We propose to change the cement we will use for the 4 1/2" production casing to: Lead cement with 225 sks Premium Cement + 0.3% Econolite + 5 lbm/sk Kol-Seal + 0.125 lbm/sk Pol-E-Flake (wt. 11.80 ppg, yield 2.52), volume: 567 49 cf, includes 75% excess. Tail with 54 sks VersaCem + 1.28 cf/sk 50/50 Poz Premium + 3 lbm/sk Gilsonite + 0.125 lbm/sk Pol-E-Flake (wt. 13.50 ppg, yield 1.28), volume: 69.03 cf, includes no excess. Centralizers will be run on the bottom 2 joints, then every 10th joint thereafter or +/- 400', and Centralizers, to impact a swirling action, will be placed just below and into the base of the Ojo Alamo.
