The Dakota formation is properly plugged in this well.

Perforate at 4841'. Top Gallup perforation is at 4891'.

Set cement retainer at 4791'.

Pump adequate Type III cement to cover 100' inside and outside casing.

Spot 100' cement plug inside casing across Mesaverde top 2476'. (2526-2426')

Perforate at approximately 1640'. Pictured Cliffs top at 1622'.

Set cement retainer at about 1630'.

Establish rate into perforation and check for returns to surface.

Pump an adequate volume of cement to cover the Ojo Alamo at 780'.

Perforate Fruitland Coal approximately 1610'-1618'.
