11-6-09 Move on to location, Rig up service unit and inspect closed loop system, no leaks. 11-10-09 Unseat pump and pump 35bbls of hot water to soften paraffin. Some scale starting at 2500'.

11-11-09 Test well to 1000 PSI, bled off. Replaced 4 joints of 2 3/8" TBG tested again, tested good,

we used the same length of TBG when replacing the 4 joints so the TBG depth is still the same as before the work over. Left pumping to tank. Good pump action. Inspected closed loop work over tank, no leaks.

11-12-09 released to pumper and moved off of location.
