While performing a routine pump repair, XTO Energy found and isolated a casing leak from 3215' - 3246'. XTO intends to set a CIBP at +/- 3280' and a packer at +/- 3190' and squeeze leak with +/- 50 sx Class G cement. Verbal approval to proceed with casing repair was given by Jim Lovato w/BLM (3:15 p.m) and Kelly Roberts w/OCD (3:40 p.m) on 12/22/09.
