Released wiper plug and displaced plug w/15 bbls FW. Bumped plug w/500 psi. Circ. 15 bbls good cement to surface. RD Schlumberger. WOC. NU WH & BOP. PT-OK. PT rams, inner choke line valve and casing to 250 psi for 3 minutes and 1000 psi for 30 minutes. Good test.
