Pumped 30 bbls FW w/dye in last 10 bbls. Pumped 450 sx (1175.7 cf - 209.4 bbls slurry) Class G cement w/3% extender, 0.25#/sx Cellophane, & 0.2% Antifoam. Tail - pumped 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% BWOC CaCl₂, 0.25#/sx Cellophane, & 0.2% Antifoam. Released wiper plug and displaced w/20 bbls FW & 117.5 bbls mud. Bumped plug w/1350 psi @ 1230 hrs 12/23/03. Circ. 27 bbls good cement to surface. RD Schlumberger. Change rams to 4.5".
