Hold safety meeting. TIH testing to 1100 PSI, found 2 joints with holes and blew 1 joint. Replaced 3 joints total, used same size and length of TBG to replace the 3 joints, so the TBG depth did not change. Load TBG with produced water and pressure test to 400 PSI, tested good. Leave well with pumper over wknd. 12-7-09 Inspect CLWO system, no leaks, hold safety meeting, pumper started unit, well was making fluid, RD and move off of location.
