Elm Ridge Exploration Co.LLC,has plugged the above well as follows;10-21-09 Plug #1,Set 4 1/2" cement retainer @ 3050' mix and pump 47 sks of cement, 12 sks below retainer and 35 sks above retainer(3050' to 2702'). 10-22-09 Plug #2, Shoot 4 holes at 1466' set cement retainer at 1416' sting out of retainer and pump 12 sks of cement on top of retainer (1466' to 1366'). 10-22-09 Plug #3, Shoot 4 squeeze holes at 142' pump down 4 1/2" casing, establish circulation out bradenhead, circulate 10 bbls of FW, circulate clean.Mix and pump 57 sks of cement down 4 1/2" casing,circulate 14 sks out bradenhead to pit. 10-23-09 Dig out cellar, cut off wellhead, install dry hole marker,cut off anchors,back fill cellar and move off of location.NOTE:All cement operations were witnessed by John Hagstrom with the BLM office,Type of cement is class G,mixed @ 15.6# PPG,1.18 Yield.
