Currently this well is unable to produce due to a high line pressure &amp; needs a wellhead compressor.

BP is performing integrity testing and modification of the proposed 3rd party wellhead compressor to meet internal BP safety & technical requirements. As soon as these requirements are met and the unit is approved a new compressor will be installed and well restored to production.

BP respectfully requests permission to continue shut-in status until internal requirements are approved. BP expects to set the compressor by the end of February and restore to production by the end of March 2010.
