1/14/04 RIH w/6-1/4" bit & tagged cement @ 3610'. Drilled out cement shoe & Drilled to 8019' (TD). TD reached 1/17/04. Circ. hole. RIH w/4-1/2", 11.6#, I-80 casing and set @ 8019'. RU Halliburton to cement. Pumped a preflush of 30 bbls 2% KCL water & 10 bbls water ahead of cement. Pumped 480 sx (696 cf 123.9 bbl slurry) 50/50 STD POZ, 3% Bentonite, 5#/sx Phenoseal, 0.2% CFR-3, 0.8% HALAD-9, 0.1% HR-5. Dropped plug and displaced w/124 bbls 2% KCL. Bumped plug to 2000 psi. Plug down @ 1008 hrs 1/18/04. No cement to surface, none planned. ND BOP, set slips and cut off casing. RD & released rig 0000 hrs 1/19/04. Will show TOC and 4-1/2" casing PT on next report.
