Tail - Pumped 100 sx (127 cf - 22.5 bbls slurry) 50/50 Class G POZ w/2% Gel, 5#/sx Gilsonite, 2% CaCl₂, 0.25#/sx Cellophane & 0.2% Antifoam. Released wiper plug and displaced w/20 bbls FW & 97 bbls mud. Bumped plug w/1120 psi @ 0630 hrs 1/12/04. Circ. 22 bbls good cement to surface. RD Schlumberger. Changed our rams to 4.5#.
