In accordance the Case 13246, Order # R-11363, it is intended to downhole commingle the Blanco MV (72319) and Tapacito PC (85920). The existing MV perforations are 5460'-6188' and the estimated PC perforations are 3740'-3788'. Selectively perforate and fracture the zone. Clean out to PBTD. Run tubing & put well on production. Recommended allocation will be by Subtraction method following 60 days of stabilized production. Commingling will not reduce the total remaining production's value. The interest owners are identical for each zone. Rates reported to NMOCD - Aztec for final determination.
