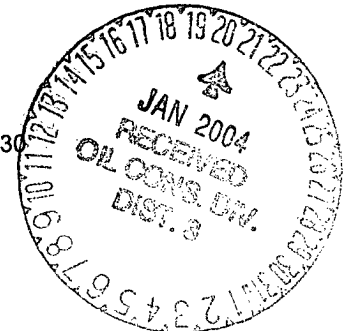

12/27/03 RIH w/8-3/4" bit & tagged cement @ 180'. Drilled out cement and then formation to 3705'. Circ. hole. RIH w/7", 20#, J-55 casing and set @ 3705'. RU Halliburton to cement. Pumped 30 bbls water w/dye in last 10 bbls. Pumped Lead - 370 sx (1064 cf - 189.49 bbl slurry) STD, 3% econolite, 10#/sx pheno-seal. Tail - pumped 220 sx (286 cf - 50.93 bbl slurry) 50/50 POZ, 2% benonite, 6#/sx pheno-seal. Dropped plug and displaced w/148 bbls water. Bumped plug w/1500 psi. Plug down @ 1830 hrs 12/31/03. Circ. 35 bbls good cement to surface. ND BOP, set slips and cut off casing. WOC. NU BOP. PT BOP - OK. PT casing to 1800 psi - 30 minutes. Good test.
