The previous operator RC Resources sent out a sundry notice with intent to plug this well. HEP Oil GP, LLC became operator on 11/1/2009 and intends to return this well back to production by fixing the casing leak. *Cancel Patch Approval*

With an approximate start date of late March 2010 (weather permitting) and a duration of 7 days:

- 1) Rig Up Service Rig.
- 2) POOH w/ 1-1/2" tubing. Move in work string.
- 3) Isolate casing leak with packer and retrievable bridge plug.
- 4) Squeeze off leak.
- 5) Drill out.
- 6) Hydrotest 1-1/2" tubing back in hole.
- 7) Return well to production.
