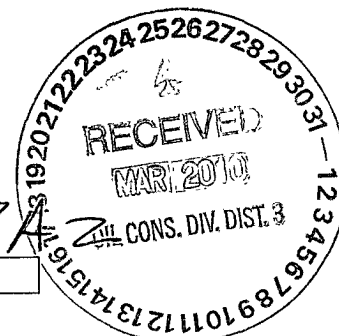
Proposed perforations are: MV - 3815' - 6210' ; DK - 7885' - 8128' These perforations are in TVD.
