04/06/10 RIH with 4.50" composite bridge plug, set @ 4050'. Run GR-OCL and CHL. Pressure test casing to 3000 psi - 30 minutes - ok. Perforate PC from 3740' - 3788'.

04/07/10 Acidize PC perfs with 1000 gals 15% HCL. Frac PC with 83,100 gals 70Q linear gel & 10,020# 20/40 sand.

04/08-11/10 Flow back frac.

04/12/10 TIH and clean out with air mist.

04/15/10 TIH with 2.375" tubing, set @ 6167'. SN @ 6135'. ND BOP. NUWH. Return to production.
