4/13/10 Set a 4-1/2" BP at 2310'. Install frac valve and pressure test to 3,500 psi - held OK. Perforated the lower Fruitland Coal at 2108 - 2123'. Total of 45 (0.50") holes.

4/15/10 Frac lower FTC with 500 gal of 15% HCl followed by 100,000# of 20/40 Brady sand in 518 bbls of 15# X-linked gel in 70% nitrogen foam.

4/18/10 Set a composite frac plug at 2054'. Perf the upper FTC at 1974' - 84' and 1998' - 2012' at 3 spf for a total of 72 (0.50") holes. Balled off the upper FTC perfs with 1000 gal of 15% HCl and 100 balls.

4/19/10 Fraced the upper FTC with 100,000# of 20/40 Brady in 562 bbls of x-linked gel water and 645,000 SCF of nitrogen.

4/23/10 -4/27/10 Cleaned out the well to PBTD with air-mist. Landed the 2-3/8" tubing at 3104' GL. Released the rig and SI well. Setting surface facilities.
