5/20/10 - Pulled packer. Tagged cement at 4287'. Drilled out at 4519'. Casing did not pass MIT pressure test requirements.

5/21/10 - Located casing holes at 4426-4455' and 4485-4516'.

5/22/10 - Spotted 200 gal 15% acid at 4522'. Squeezed 15 sx cement at 14.8 ppg Type III into leaks at 4426-4516'.

5/24/10 - Drilled out 4357-4518'. Casing did not pass MIT pressure test requirements.

5/25/10 - Retrieved RBP.

5/26/10 - RDMO. Plan to P&A well as previously approved.

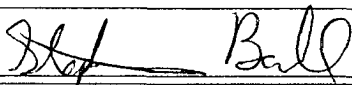
