5/21/10 - Drilled out at 297'. Casing did not pass MIT pressure test requirements.

5/22/10 - With RBP at 2152', located casing hole from 277-287' using packer. Pumped 200 gal 15% HCL. Pumped 50 sx Type II cement at 14.8 ppg, 1.32 yield. Casing did not pass MIT pressure test requirements.

5/24/10 - Drilled out at 280'. Casing did not pass MIT pressure test requirements.

5/25/10 - Retrieved RBP. RDMO. Notice of Intent to P&A well will follow.
