Cement with 530 sks PRB-II, 5#/sk gilsonite, 1/4#/sk flocele tailed by 50 sks PRB-II, 5#/sk gilsonite, 1/4#/sk flocele (1049 cu.ft.). Plug down @ 1:30 pm on 06/11/10. Did not circulate cement to surface. WOC. RD Halliburton. Run temperature survey, TOC @ 60'. NU BOP. Test casing to 1500 psi - 30 minutes - ok. Test BOP to 250 psi, low - 15 minutes and to 2000 psi, high - 15 minutes - ok.
