The subject well is a new drill project where cement was not circulated to surface on the 7" casing string set @ 3630'. A temperature survey was ran and found TOC @ 1400' with temperature anomalies @ 980'. After review with Jim Lovato & Adrienne Garcia at the BLM, it was decided no remediation is required at this time. However, the 7" x 9-5/8" annulus must be monitored for pressure during the remaining drilling operations and before and after completion operations. Furthermore, the annulus must have a bradenhead test performed yearly to verify any pressure communication to surface.
