XTO would like to request approval for exception to calibrating the meter during this temporary abandonment period. Prior to returning the well to production, the meter will once again be calibrated as required.

XTO does not anticipate any fluids returning out of the wellbore during the TA procedure, therefore we do not see needing a C144-CLEZ permit at this time.

4. TIH w/5-1/2" cement retainer and set at 5,740'. TOH.
5. Pressure test cement retainer to 550 psi and record on chart for 30 min.
6. RDMO PU.
