Pumped a preflush of 10 bbls dye water. Pumped 150 sx (201 cf) 50/50 STD/POZ, 2% Bentonite, 5#/sx Gilsosnite 0.2% CFR-3, 3% CaCl2, 0.25#/sx Cello-flake. Dropped plug and displaced w/15 bbls water. Bumped plug w/250 psi @ 1418 hrs 1/20/04. Circ. 15 bbls cement to surface. WOC. NU WH & BOP. PT-OK. PT rams, manifold - 300# for 3 minutes and 1000 psi for 10 minutes. PT casing to 1000 psi for 30 minutes. Good test.
