We are currently increasing the line size in the area to provide a lower operating pressure and provide a measure of safety for pipeline pressures. Construction will be complete in the next few weeks. Once the gathering system is complete, we well begin well completion and bring the wells to production. We request that we be given until December 31, 2010 to place this well on production.
