Please consider the referenced well for an exception to the new seasonal drilling restrictions. We submitted the application for permit to drill this well on 1/2/2003 and received approval from the BLM on 1/20/2004. The approved application for permit to drill stipulated, "The location of the proposed action is located within a designated Big Game Winter range area. Big Game Winter wintering range area will have no construction drill or completion activities conducted between December 1 and March 31". We intend to drill, complete, and get pipeline ROW completed during the restricted time. The activities are planned to start on February 8, 2004 and be completed by the end of March 2004.

*Approved to drill no sooner than March 1, 2004 contingent upon no unusually adverse weather. Call John Hansen 505-599-6325 prior to drilling on March 1.*
