8/16/10 Conversations with Steve Mason (BLM) & Kelly Roberts (NMOCD). BP requests permission to leave well in Shut In status for a short period of time in order to bring equipment back to the location, hook up and restore well to production.

BP respectfully requests permission to cancel the P&A procedure.
