Energen Requests that the above well be Allowed as a Temporary Abandon to hold the wellbore for 80 Acre Downspacing in the Fruitland coal. The well will be TA as follows:

1. A 5-1/2" casing plug will be set @ +/- 3,921' above the top perf located at 3,971' - top of Fruitland @ 3,767')

2. The well will be loaded with an inhibited packer fluid and the casing will be tested to 500 psig for 30 minutes with no more than 10% pressure loss.

3. A 2-3/8" kill string will be left in the well and a master valve will be left on the tubing head - all casing side/outlet valves will be left in place will bull plugs and the well will be totally disconnected from any lines.

4. Energen will annually update on the status of the 80 Acre infill and will submit a subsequent report either requesting a conintued status of TA. If a change of status is needed to producing(i.e. 80 Acre infill approved)or to plug and abandon the well Energen will submit a NOI.

5. The casing pressure test is good for 5 years - at which point if the well is still not activated another casing MIT will have to be performed on the well.

BLM-NMOCD will be notified 24 hours in advance of pressure testing the casing.
