On September 3, 2010, 7 jts. (302') of 9 5/8" 36# J55 surface casing were run in 12 1/4" hole, set @ 300', and cmtg. to the surface w/ 146 sx. (205 cubic feet) of Type III cmt. containing 2% CaCl2 and 1/4#/sk. celloflake. Pmpd. 13 Bbls. to the catch pit. PD @ 3:57 PM. There was a float shoe on bottom, a float collar 1 jt. up, a centralizer on the jt. between the shoe and float collar and 4 centralizers on the next 4 casing collars.

On September 4, 2010, the surface csg. was pressure tested to 1500 psi and tested okay.
