CBM Partners plans to drill this well to approximately 4300'. The cement program will be changed from a single stage job to a two stage job with the stage tool placed at approximately 2800'. The first stage will consist of 150 sx (314 cu.ft.) of Premium Lite 65/35 poz with 8% gel and 1/4 pps celloflake (Yield 2.09 cu.ft./sk and wt = 12.1 ppg). Tail with 100 sx (139 cu.ft.) of Type 5 cement with 1/4 pps celloflake (Yield - 1.39 cu.ft./sk and wt = 14.5 ppg). Volume calculated with 100% excess to circulate the stage tool. The second stage will consist of 285 sx (596 cu.ft.) of Premium Lite 65/35 poz with 8% gel and 1/4 pps celloflake (Yield 2.09 cu.ft./sk and wt = 12.1 ppg). Tail with 100 sx (139 cu.ft.) of Type 5 cement with 1/4 pps celloflake (Yield - 1.39 cu.ft./sk and wt = 14.5 ppg). Volume calculated with 75% excess to circulate cement to surface.
