7/28/10 - Ran 212 joints 2-3/8" 4.7 #/ft EUE 8rd J-55 tubing.
7/29/10 - Swabbed. Parted sandline. Pulled tubing. Retrieved swab tools.
7/30-8/5/10 - Ran tubing back in well.
8/31/10 - RIH with 262 3/4" Grade D rods and 1-1/4" pump. Set pumping unit. Return well to production.
