Elm Ridge Exploration Co., LLC recently performed a workover on this well to restore production. The wellhead pressure is once again adequate for plunger lift operations, but the plunger lift surface line needs to be replaced. This work is planned for the week of September 20, and we expect that the well will be returned to production by September 27, 2010.
