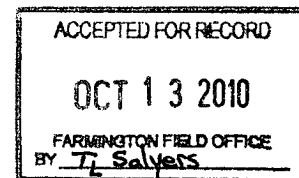

Cement with 250 sks Class G, 2% CaCl2, 1/8#/sk flocele (300 cu.ft.). Plug down @ 8:30 pm on 09/22/10. Circulate 30 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing to 1500# - 30 minutes - ok. Test BOP to 250#, low - 10 minutes and to 2000#, high - 10 minutes - ok.
