Circulate 6 bbls cement to surface. Plug down @ 3:00 pm on 10/07/10. WOC. RD Halliburton. NU BOP. Test BOP to 250#, low - 5 minutes and to 2000#, high - 10 minutes - ok. Pressure test casing to 1500# - 30 minutes - ok.
