Plugging and Abandonment Operations:

July 23 through July 27, 2010: MIRU well service unit. Install weight indicator. POOH w/ rods and downhole pump. Lay down. Drop standing valve. Load tbg to 1000 psig - OK. NDWH. NUBOP. POOH w/ 2 3/8" tbg. RIH w/ 4 1/2" squeeze retainer. Assembly on 113 jts 2 3/8" tbg and land @ 3461'. Load tbg and circulate 15 bbls water past retainer. Set retainer and shear off. Pump dn tbg and circulate up csg w/ 3 bbls displaced. Sting into retainer and establish inj rate of 2 BPM at 560 psig through perfs @ 3805'-3819'. Then mix and squeeze perfs w/ 37 sx cement and displace w/ 3 bbls water. Sting out of retainer w/ 179 psig in tbg. Left 5 sx cmt to fall on top of retainer. POOH w/ tbg. RIH and perf 4 holes @ 2200'. RIH w/tbg and set @ 2250'. Pack off tbg and cement dn tbg w/50 sx cement @ 1 1/2 BPM @ 500 psig. POOH w/tbg. Fill hole. RIH and perf 4 holes @ 325. RIH w/ tbg and land @ 373'. Mix and pump 170 sx cement dn tbg @ 3 BPM @ 800 psig. Cement circulated to surface. POH w/ tbg. NDBOP. Rig down and move out.
