On 3-8-10, Williams filed to P&A this well. We had previously plugged back this well in April, 2009 with plugs set at 3528'-3810' and at 4149'-4652'. At this time we would like to withdraw our request to P&A this well and instead request that the well be placed back on Temporarily Abandon status for a period of one year. On April 14, 2009 after plug back operations, casing was tested to 800 psi, good test. This test was reported on subsequent report sundry filed 4-24-09. We would like to save the wellbore for possible future development.
