Energen TA'd the above well (See NOI dated 9/2/2010 from Energen)

The well was TA as follows:

Work from 10/18 to 10/26/2010

1. A 5-1/2" casing plug set 3,636' - top of Fruitland @ 3,534'

2. The well was loaded with an inhibited packer fluid and the casing was tested to 700 psig for 30 minutes with no more than 10% pressure loss. (both BLM and NMOCD notified no witness for either agency - told to proceed by NMOCD.-Sam Mohler to take charts to NMOCD)

3. A 2-3/8" kill string was left in the well and a master valve on the tubing head - all casing sideloutlet valves left in place with bull plugs and the well is totally disconnected from any lines.

4. Energen will annually update on the status of the 80 Acre infill and will submit a subsequent report either requesting a conintued status of TA. If a change of status is needed to producing(i.e. 80 Acre infill approved)or to plug and abandon the well Energen will submit a NOI.

5. The casing pressure test is good for 5 years - at which point if the well is still not activated another casing MIT will have to be performed on the well.

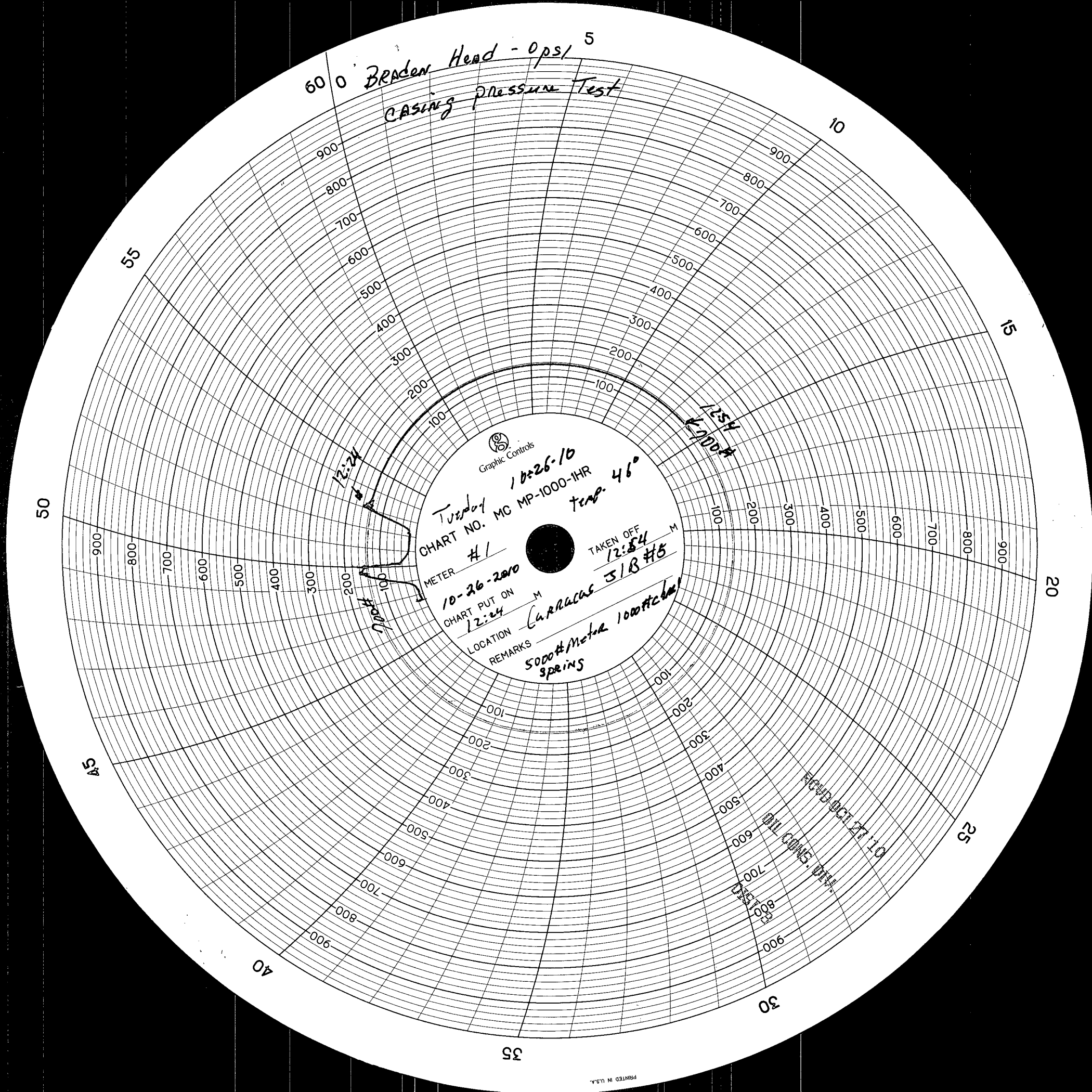
