Reference is made to the following:

- (a) your application (administrative application reference No. pTGW10-18355945) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on July 2, 2010, and
 - (b) the Division's records pertinent to this request.

Benson-Montin-Greer Drilling Corp. [OGRID 2096] (BMG) has requested to drill the above-referenced well at an unorthodox oil well location, described above in the caption of this letter. Section 27 will be dedicated to this well in order to form a standard, 640-acre oil spacing and proration unit in the West Puerto Chiquito-Mancos Pool (50440). Spacing in this pool is governed by the Special Rules for the West Puerto Chiquito-Mancos Oil Pool, adopted by Order No. R-6469-B, issued in Case No. 8715 on March 7, 1986, which provide for 640-acre units with one well per unit, to be located not less than 1650 feet from a unit outer boundary, or 330 feet from a quarter section line. This location is less than 1650 feet from the southern and eastern unit boundaries.

Your application has been duly filed under the provisions of Division Rules 15.13 and 4.12.A(2).

It is our understanding that you are seeking this location for topographic reasons.

It is also understood that notice of this application to offsetting operators or owners is unnecessary due to common ownership.

Dear Mr. Brooks:

Benson-Montin-Greer Drilling Corp. (BMG) requests the State of New Mexico Oil Conservation Division's approval to drill the Canada Ojitos Unit (COU) # 46 in the following unorthodox location: 424' FSL and 281' FWL, Unit P, Sec 27, T25N, R1W Rio Arriba County New Mexico. This well is intended to be drilled and completed in the Mancos formation.

The well will be drilled in the Canada Ojitos Unit; all adjacent sections to section 27 are within the Canada Ojitos Unit. The Mancos interest owners have the same interest throughout the unit.

The location of this well was selected to maximize the benefit of naturally fractured reservoir characteristics as derived from seismic data. The location selection is further affected by topography and by the need to minimize surface disturbance within the Santa Fe National Forest.

The nearest producing well (BMG's COU # 14, a Mancos producer) is approximately 3100 ft west/southwest of the proposed COU # 46 site.

We are submitting the following:

- 1. A copy of the NM OCD form C-102.
- 2. Nine-section map of the surrounding area with location of the other producing Mancos wells.
