This well was previously completed in the Blanco-Mesaverde (f/4846' - 5478') and the Basin-Dakota (f/7352' - 7574'). On 4 Oct 2010 Chevron pulled the dual completion equipment out of the well, acid treat both formations through their respective perforations, and DHC both zones within the wellbore. The DHC allocation is as follows:
