This well was re-delivered on 10/25/2010 and produced natural gas and entrained hydrocarbons.

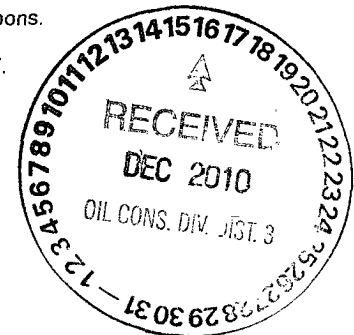
