XTO Energy Inc. requests an exception to NMOCD Rule 19.15.12.9 to permit DHC of the Basin Fruitland Coal (71629) & the West Kutz Pictured Cliffs (79680) pools in the Schwerdtfeger 8 #3. Both pools are in the NMOCD pre-approved pool combinations for DHC in the San Juan Basin per order R-11363. XTO proposes to DHC these pools upon completion of the PC. Please see attached spreadsheets for justification of proposed allocations. Recommended allocations are as follows:

West Kutz Pictured Cliffs:	Oil: 100%	Gas: 86%	Water: 32%
Basin Fruitland Coal:	Oil: 0%	Gas: 14%	Water: 68%

Ownership is diverse & notification was made without protest by CRR on 1/24/2011. DHC will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights. The NMOCD was notified of our intent to DHC via Form C-103 on 2/14/2011.
