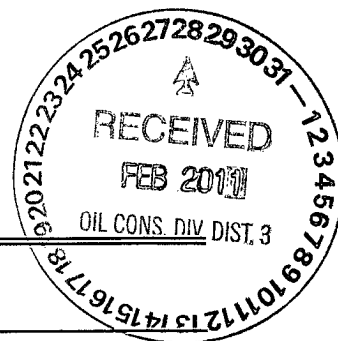

We propose to remove the 18" conductor pipe that was set at a depth of 15' in 2008. The conductor was not cemented and no water was encountered. Location will be reclaimed, but left suitable for drilling at a later time if gas prices should warrant it to become economical.
