Pumped a preflush of 30 bbls FW w/dye in 1st 10 bbls. Pumped Lead - 455 sx (1187.6 cf - 211.5 bbl slurry) Class G cement w/3% extender, 0.25#/sx cellophane, & 0.2% antifoam. Tail - Pumped 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% Gel, 5#/sx Gilsonite, 2% CaCl₂, 0.25#/sx Cello-phane, & 2% Antifoam. Dropped plug and displaced plug w/20 bbls FW & 118 bbls mud. Bumped plug w/1250 psi @ 0707 hrs 2/8/04. Circ. 36 bbls good cement to surface. RD Schlumberger. Changed rams to 4-1/2", ND BOP & PU stack. Set slips and cut off casing. Installed trash cap. RD & released rig @ 1600 hrs 2/8/04. Will show casing PT on next report.
