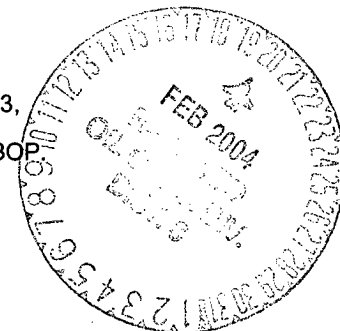

Pumped a preflush of 10 bbls dye water ahead of 150 sx (201 cf) 50/50 STD POZ, 2% Bentonite, 5#/sx Gilsonite, 0.2% CFR-3, 3% CaCl2, 0.25#/sx Cello-flake. Dropped plug and displaced w/15 bls water. Bumped plug to 355 psi. Plug down @ 1651 hrs 2/14/04. Circ. 12 bbls good cement to surface. WOC. NU WH & NU BOP PT-OK. PT casing to 1000 psi for 30 minutes. Good test.
