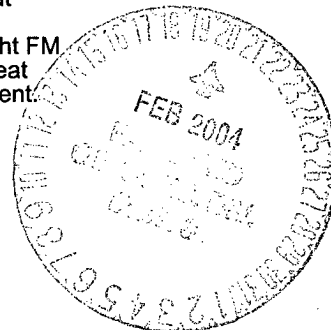

Tail w/100 sx neat cement 1% CaCl₂, 1/4# celloflake/sx. Total cement 1782 cu ft. Circ 30 bbls contaminated cement.
