The surface cement slurry has been changed for the following wells to:
Cement with Type III cement with 0.25 pps Celloflake, 3% calcium chloride. (1.28 yeild, 15.2 ppg, 200% excess, bring cement to surface). Wait on cement appropriate time until cement achieves 250 psi compressive strength at 60 degrees F. prior to nipple up of BOPE. Wait on cement for 8 hrs for conventionally set holes before pressure testing or drilling out from under surface. Test casing to 600 psi for 30 minutes.
