Pre-flush w/ 20bbls pre-flush, 10bbls FW. Pumped 76sx (122cf-22bbls=1.60 yld) Pre-mix w/ 20% Fly-ash. Drop plug & displaced w/ 5bbls FW. Cmt locked up w/ no cmt to sfc. Top set with 34 sx (47cf – 22 bbls – 1.39 yld) neat cmt. Cir. 1 bbl to sfc. NUWH. RD & MO 4/3/11.

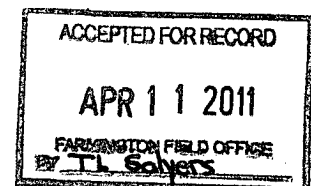
