

**Describe Cause of Problem and Remedial Action Taken.\***

The below grade tank overflowed into the bermed area. All fluids were contained inside the bermed area. A vacuum truck was used to recover the free liquids standing in the bermed area.

**Describe Area Affected and Cleanup Action Taken.\***

The below grade tank and the storage tank were moved so that the impacted soil around and beneath the equipment could be removed. Impacted soils are being excavated and transported to a commercial disposal facility. Once the impacted soils are removed, samples will be collected from the excavation and sent to a laboratory for analysis. The final C-141 submittal will include the lab reports.
