Oil dump line stuck open (frozen) and caused gas to spray oil out of tank. Free standing oil recovered from within berm with vacuum truck. Additional residual oil was recovered by floating oil with hot water wash equipment and vacuum truck. Soil impacted was frozen and primarily a clayey soil type. Impacted soil will be removed and land farmed on location.
