XTO Energy Inc. proposes to recompleate this well to the Basin Mancos zone and put the well on a pump per the following procedure:

MIRU. Set a CIBP at 5950'. Perforate the Mancos from 5544'-5121' at 2 JSPF, .36" dia, 22.7 gm, 48 total holes. Acidize the Mancos with 1,500 gals 15% HCl. Frac the Mancos with 96,000 gals frac fluid carrying 120,000# 20/40 proppant. Clean out to 5950'. Run tubing and rods and return the well to production. If DHC has not been approved, the Mancos zone will be tested for several months. Once DHC is approved, we will clean out to PBTD and return both zones to production.
