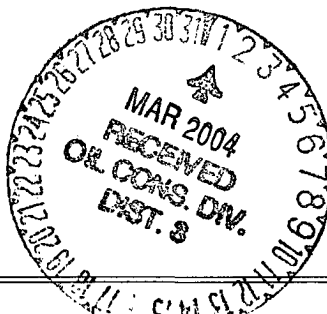

Pipe will operate at 50 psi. Test pressure = 125 psi. Burst pressure = 630 psi @ 60° Celsius.
Joints will be joined with butt heat fusion. Route will be intervisibly posted with markers.
On lease portion = 827.53'. Off lease will be authorized with BIA right-of-way.
